BCAC's mission and important work will remain unchanged, and it will now operate at 475 Clinton Avenue, Bridgeport, as *Bridgeport Child Advocacy Coalition: The Center for Research and Advocacy at LifeBridge Community Services*.

The merger will provide both LifeBridge and BCAC with a larger platform and greater reach while helping to strengthen and enhance the effectiveness of each other's services. Both organizations share a commitment to providing greater Bridgeport's most vulnerable children and families with the high-quality social services, research and advocacy and resources they need to reach their full potential.

LifeBridge Community Services annually provides comprehensive social services to over 17,000 low-income individuals and families through four core programs: Economic Empowerment, Youth Services, Behavioral Health and Social Enterprises ranging from Meals on Wheels to Deaf Interpretation Services. LifeBrige will work closely with BCAC to research and analyze data to identify unmet needs in the community, measure program effectiveness, generate support for programs and services with proven results and mobilize the wider community to achieve greater impact.

"Maximizing our collective impact is the driving force behind this merger" says Bill Hass, President & CEO of LifeBridge. "BCAC brings over 30 years of experience and leadership focused on building a broad-based and effective coalition of local and state-level policy makers, educators, law enforcement, health care providers, clergy, community leaders and families. They are a strong and independent voice for grassroots advocacy, research and policy development, and systems change. Public and private organizations throughout the state rely on BCAC's annual *State of the Child* report, and the critical data-based information it contains on the health, safety, education and economic status of greater Bridgeport's children and families to help guide their efforts."

Mary Pat Healy, immediate past executive director of BCAC, will continue to lead the program at LifeBridge. She is also excited about the collective impact of the merger. "We believe this will enable LifeBridge to more effectively serve their clients and advocate on their behalf, while enabling us to continue our research and work to effect policy and systems change that address the impact of poverty, injustice and inequality on our community. In today's economic environment, cost savings and efficiencies are important considerations but, at the end of the day, this merger brings both agencies more vigor and creativity in developing "champions for change".
